This privacy statement contains data management/processing information related to the conduct of the annual Premier Music International Competition. This privacy statement relates only to online entries to the competition.

Information on data management: The purpose of data management is to provide an online entry for the competition.

Legal basis for data management: Legitimate interest of dB PMIC (Section 6 (1) (f) GDPR). Data management is necessary to organize the competition. Given the international nature of the competition, dB PMIC provides applicants with the opportunity to apply online.

Stakeholders: persons applying for the competition, or their guardians in case of a minor applicant.

Personal data:

Surname and First name (purpose: identification of the applicant);

Date of birth

For applicants under 18, the name and e-mail address of the parent / guardian

Country of origin

Instrument

Duration of instrumental studies

Style (classical, pop/rock, jazz)

Competition category (solo or chamber music/band)

E-mail address (purpose: to make a connection in order to conduct the competition);

A piece of video recording as part of the competition repertoire

Duration of data retention:

we retain the data until revoked by the applicant, at the latest after the statutory period. Recipients: members of the jury and designated staff of the data controller.

Attention: A fully completed application form is the condition to be able to participate in the competition

Access to data:

The personal data provided during the online application can be accessed by the following persons: staff of dB PMIC involved in organizing the competition; who may access and manage the personal data provided during the application only in connection with the conduct of the competition.

Only those data and videos required to make a decision will be forwarded to the members of the jury. dB PMIC will make every effort to prevent a data protection incident from occurring, otherwise it will respond to the incident within the time specified by law and will also make the appropriate reports.

The information you provide is stored on a server operated by the hosting provider. The data can only be accessed by our employees and the employees operating the server, but they are all responsible for the secure handling of the data.

Name of the activity: hosting service, server service.

The purpose of data management is to ensure the operation of the website.

3. In the event of unlawful data processing, you may take legal action against the data controller.

As data controller, dB PMIC makes every effort to ensure that data processing related to the competition is regulated by Act CXII of 2011 on the Right To Information Self-Determination and Freedom of Information (Infotv.) and Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation, abbreviated as GDPR).
